Section 12.08.130 **ELECTRICAL WIRING FEES EFFECTIVE MARCH 1, 2004**

All fees listed below (Sec. B through I) exclude the cost of service.
(Sec. K) Permit fees are not transferable.

(A) Electrical Services

1. Fee for all electrical services and generators shall be at the rate of \$.30 per amp with a \$30.00 minimum.
2. Service panel board changes are equivalent to service changes.

60 amps - \$ 30.00
100 amps - \$ 30.00
200 amps - \$ 60.00
400 amps - \$ 120.00
800 amps - \$ 240.00

(B) Residential, New, Additions and Alterations with Building Permit

One-Family
Two-Family
Multi-Family

\$70.00 per dwelling unit

(C) Residential Miscellaneous with Building Permit

Hotels
Motels
Dormitories
Nursing Homes
Rooming Houses, etc.

\$80.00 + .10 per square foot

(D) Change of Use Group

Change of any use group to residential shall be treated the same as listed in Sections A, B and C.

(E) Accessory Work Items

Accessory Buildings, separate garages, temporary trailers	\$50.00
Major Appliances (e.g. air conditioner)	\$30.00
Oil or Gas Burner	\$30.00
Above Ground Pool	\$40.00
In-ground Pool	\$60.00
Smoke Detectors (per detector)	\$10.00
Pole Lights	\$50.00 + \$10.00 per pole
Wiring of Signs	\$40.00

- (F) Residential (no building permit required)
 Minimum Fee \$25.00 + \$5.00 per room
 Exception: Residential Alarm Systems \$40.00
- (G) Commercial (new, additions and alterations with building permit)
 \$80.00 + .10 per square foot

The **only** exceptions are:

- open canopies
- open warehouse space
- open parking garage space

\$80.00 + .08 per square foot

- (H) Commercial (no building permit required)

Repairs, Wiring Additions Only
 Lighting Retrofits
 Comfort Control Systems
 Communication Systems, etc.
 Fire Alarm and Security Alarm Systems

\$80.00 first floor + \$30.00 each additional story

- (I) Maintenance Permits

Any business operation which maintains an electrical maintenance force shall pay a blanket fee of

\$500.00 annually for work done on premises subject to the following:

- a. the permit application and fees are due the first day of January each year
- b. any work done by outside contractors is subject to appropriate action of this schedule
- c. a log of work completed shall be kept by the supervisor of electrical maintenance and arrangements shall be made for the wiring inspection semi-annually

- (J) Permit Re-Issuance Fee
 \$40.00 or original permit fee if less than \$40.00

- (K) Temporary Wiring: In conjunction with bazaars, outdoor shows, exhibitions, carnivals, etc. \$70.00

- (L) Any Fee Not Covered By The Above: Building Commissioner shall determine the fee

- (M) Occupancy Permit Application: \$50.00

- (N) Buildings Owned By The City of Springfield: exempt from requirements of this fee schedule

PERMITS ISSUED AND NO WORK COMMENCED WITHIN (6) SIX MONTHS OF ISSUANCE DATE WILL NO LONGER BE HELD. A NEW APPLICATION MUST BE

TAKEN OUT.
