U3 - Court Square Urban Renewal Area

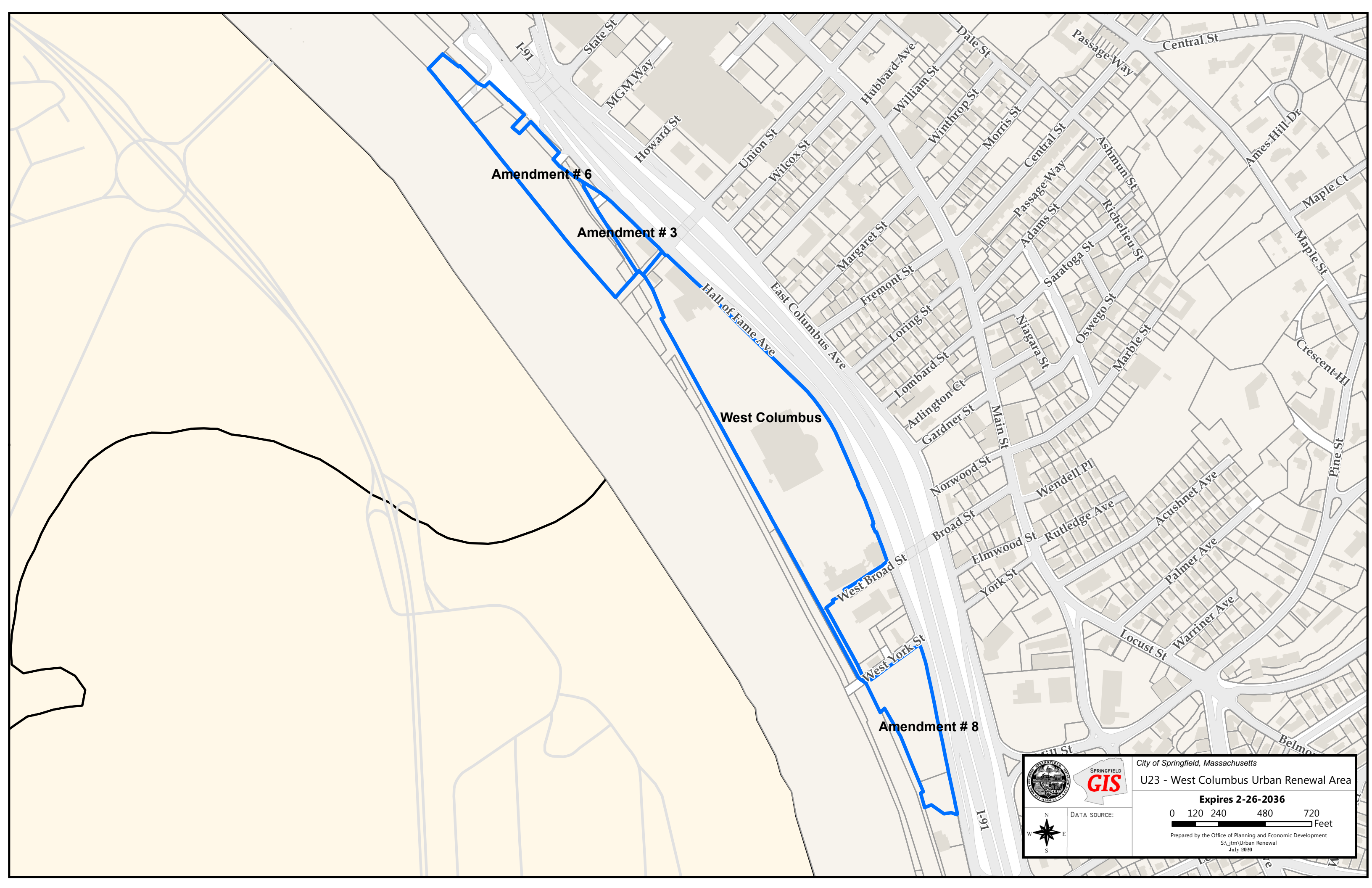

Tapley Urban Renewal Area



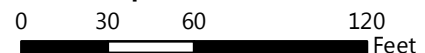

U32, U35, U36 - McKnight Urban Renewal Area





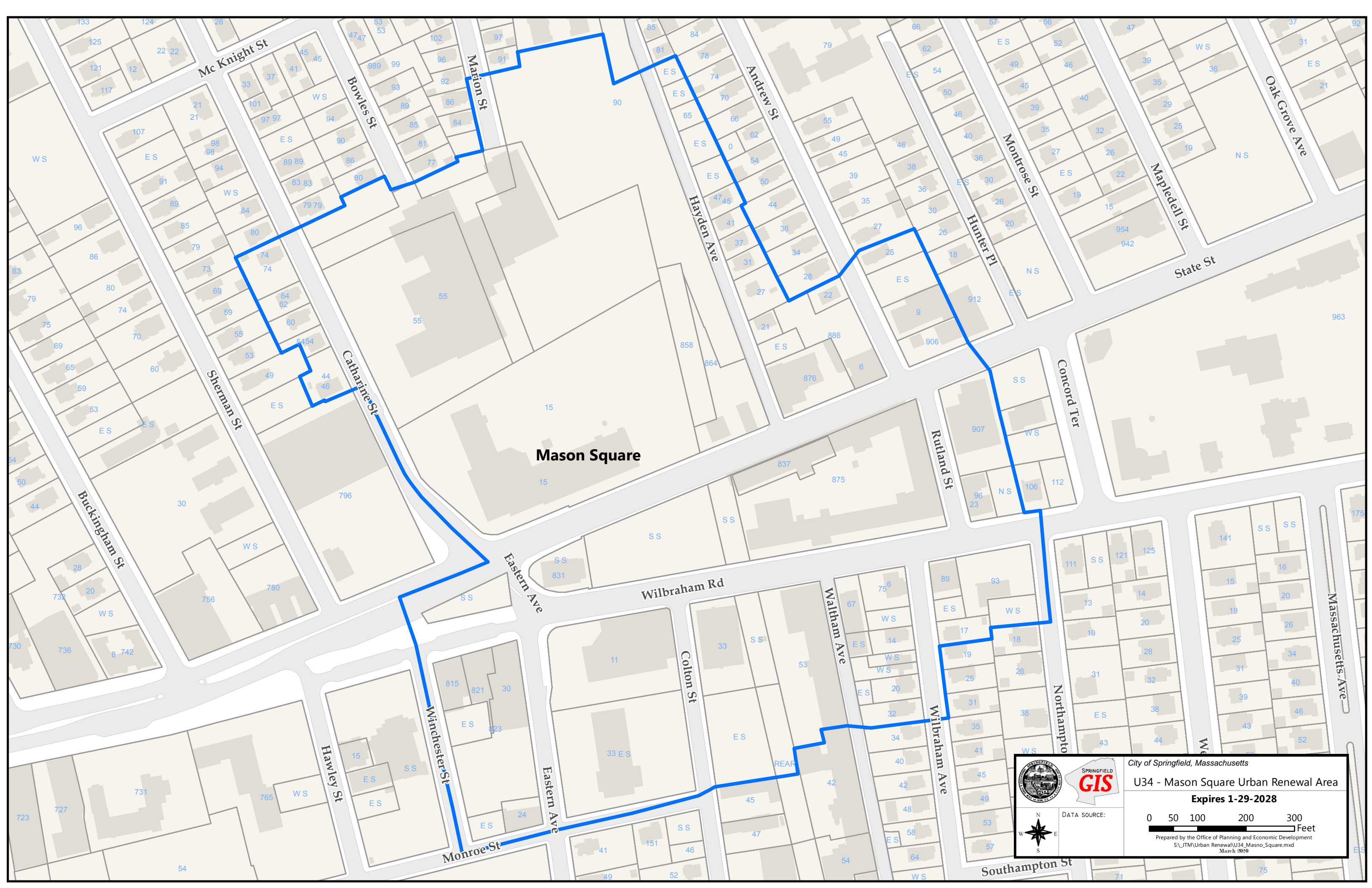
